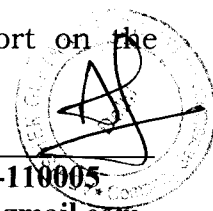

As requested by management I submit herewith my combined report on the results of e-voting together with that of poll as under :-


